Methodology | Virginia 2020

Club for Growth Foundation publishes the scorecard study so the public can monitor the actions and the voting behavior of Virginia's elected state lawmakers on economic growth issues.

The Foundation conducted a comprehensive examination of each lawmaker's record on votes related to pro-growth policies and computed an Economic Growth Score on a scale of 0 to 100. A score of 100 indicates the highest support for pro-growth policies.

The Foundation examines legislative votes related to the Club's immediate pro-economic growth policy goals, including:

- Reducing or eliminating tax rates and enacting tax reform
- Limited government through limited spending and budget reform
- Regulatory reform and deregulation
- Ending abusive lawsuits through medical malpractice and tort reform
- Expanding parental choice for education
- Implementing term limits

Not all of these policy goals will come up for a vote in each legislative session.

The Foundation also examines votes on bills that would directly harm these goals.

This scorecard is based on selected votes of importance to the Foundation, and does not include the complete voting record of any legislator. There are inherent limitations in judging the overall qualifications of any legislator based on a selected voting record, and the Foundation does not endorse or oppose any legislator for public office.

LEGISLATIVE ACTIONS **CONSIDERED IN VIRGINIA IN 2020**

The Foundation's study examined over 6.700 floor votes and, in the end, included 24 Virginia House votes and 24 Virginia Senate votes.

COMPUTATION

Scores are computed on a scale of 0 to 100. Each vote or action in the rating is assigned a certain number of points depending on its relative importance. If a lawmaker casts a correct vote, the scorecard will denote it with that number. If a lawmaker casts an incorrect vote, the scorecard will denote that vote with a hyphen (-). Absences are not counted - signified as an "X" on the scorecard - though the Foundation reserves the right to do so if, in its judgment, a lawmaker's position was otherwise discernible. If a lawmaker was not officially sworn into office at the time of a vote, the scorecard will denote that vote with an "I".

To provide some additional guidance concerning the scores, each lawmaker was ranked. Lawmakers with 0% scores are, by default, ranked #100 in the House and #40 in the Senate. If applicable, the study also records a "Lifetime Score" for each lawmaker. This is a simple average of the scores from 2020 and all previous years where the lawmaker earned a score.

In some cases, a lawmaker was not present for enough votes for a meaningful score or ranking to be computed. In such cases "n.a." for "not applicable" appears. In computing lifetime scores, years with "n.a." listed instead of a score are not included. Comparing such scores to other members without "n.a." years may be misleading.

ADDITIONAL FACTORS

A study of roll call votes on the floor of the Virginia House and Virginia Senate and legislative actions is just that. It cannot account for a lawmaker's work in committee. advocacy in his party's caucus meetings, and effectiveness as a leader in advocating pro-growth policies.

HB 119

STATE CONTROL OF THE WORD "MILK" (CFGF OPPOSES)

This bill would narrowly define milk as the "lacteal secretion of a healthy hooved mammal" and therefore ban all products misbranded as milk. Products like almond milk and soy milk are named as such because its producers want to compete against animal milk. For the government to prevent this is to stifle commercial speech and reduce competition. The Virginia House passed this bill, 66-32, on January 29, 2020. The Virginia Senate passed it, 24-16, on February 27, 2020.

HB 395

INCREASE MINIMUM WAGE

(CFGF OPPOSES)

The minimum wage is a price control on labor. Increasing or expanding the minimum wage often has the opposite desired effect, leading to job losses and shortages. This bill raises the state's minimum wage gradually from its current federally mandated \$7.25 per hour in 2020 to \$15.00 per hour in 2026. The Virginia House passed this bill, 53-45, on March 7, 2020. The Virginia Senate passed it, 21-17, on March 8, 2020.

HB 408

EXTENDING GREEN JOB SUBSIDIES

(CFGF OPPOSES)

This bill would extend the sunset date for the Green Job Creation Tax Credit from January 1, 2021, to January 1, 2025. This tax credit is an example of social engineering using arbitrary targets and dollar amounts. It's not a core function of government, but instead egregious corporate welfare. The Virginia Senate passed it, 27-13, on February 20, 2020. The Virginia House passed it, 58-40, on February 24, 2020.

HB 534

NEW PLASTIC BAG TAX

(CFGF OPPOSES)

This bill would allow local governments to charge a 5-cent tax on plastic bags provided

to customers by certain retailers. This is social engineering and is not an equitable way to raise taxes for financing the core functions of government. The Virginia House passed this bill, 52-47, on March 5, 2020. The Virginia Senate passed it, 22-18, on March 7, 2020.

HB 570

ALLOW INCOMPETENT TEACHERS TO KEEP WORKING

(CFGF OPPOSES)

This bill would remove the definition of "incompetency" for the purpose of establishing grounds for the dismissal of public school teachers. Teachers need to be subjected to more competition, not less, in order to make sure that the very best instructors are teaching our children. The Virginia House passed this bill, 57-42, on February 4, 2020. The Virginia Senate passed it. 22-18, on February 17, 2020.

HB 582

ALLOW PUBLIC EMPLOYEES TO UNIONIZE (CFGF OPPOSES)

This bill would permit counties, cities, and towns to adopt local ordinances authorizing them to recognize labor unions for certain public employees, including employees at governmentrun schools. This will further raise the cost of maintaining government bureaucracies, placing a higher burden on taxpayers. The Virginia House passed this bill, 53-46, on March 7, 2020. The Virginia Senate passed it, 21-18 on March 8, 2020.

HB 755

NEW UGLY PROPERTY TAX

(CFGF OPPOSES)

This bill allows certain local governments to levy a higher property tax on properties that it deems as blighted or having derelict structures. This is social engineering and is not an equitable way to raise taxes for financing the core functions of government. The Virginia Senate passed this bill, 23-15, on February 21, 2020. The Virginia House passed it, 59-39, on February 25, 2020.

HB 1141

VIRGINIA HEALTHCARE MUST BE OBAMACARE

(CFGF OPPOSES)

This bill would require health insurance companies to only offer plans that are compliant with Obamacare requirements, even if Obamacare is repealed. This will reduce healthcare freedom and choice while raising prices for everyone. The Virginia House passed this bill, 61-37, on March 5, 2020. The Virginia Senate passed it, 22-18, on the same day.

HB 1162

NEW AUTHORITY TO PURSUE ENVIRONMENTAL JUSTICE

(CFGF OPPOSES)

This bill states that Virginia's Department of Environment Quality is now supposed to further "environmental justice". Such a policy will likely reduce economic growth by rejecting building permits, tightening environmental regulations, and restricting development, especially in lowincome areas. The Virginia Senate passed this bill, 21-19, on February 24, 2020. The Virginia House passed it, 53-43, on February 26, 2020.

HB 1238

MORE POLITICAL SPEECH REGULATIONS

(CFGF OPPOSES)

Current law states that political advertisements must have a disclosure of at least a font size of seven. This bill would require the font size to be proportional to the advertisement, setting up a myriad of regulations since candidates use different methods of advertisements. The Virginia House passed this bill, 81-14, on February 6, 2020. The Virginia Senate passed it, 35-5, on February 24, 2020.

HB 1318

EXTENSION OF HOLLYWOOD TAX CREDITS

(CFGF OPPOSES)

This bill extends the sunset deadline from January 2022 to January 2027 for the motion picture tax credit that the state currently offers. This is corporate welfare and is not a core function of government. The Virginia House passed this bill, 67-26, on March 4, 2020. The Virginia Senate passed it, 35-4, on March 7, 2020.

HB 1361

CORPORATE WELFARE FOR TRUCK COMPANY

(CFGF OPPOSES)

While the legislation doesn't explicitly say it, this bill was created so that one company - The Volvo Group - could receive a direct cash payment of over \$16 million if certain performance standards are met. This is corporate welfare where lawmakers and bureaucrats get to pick winners and losers in the marketplace. This is not a core function of government. The Virginia House passed this bill, 90-9, on January 31, 2020. The Virginia Senate passed it, 40-0, on February 20, 2020.

HB 1414

HUGE TRANSPORTATION TAX AND SPEND BILL

(CFGF OPPOSES)

This massive bill would increase the state gas tax by ten cents over two years and then index it to inflation. It would also impose a new fee on electric or alternative fuel vehicles, and impose a new regional fuels sales tax in parts of the state that don't already have one. It also creates a new rail authority that would be allowed to acquire land via eminent domain to promote and create new rail service. The bill would raise over \$168 million a year in new revenue from the tax hikes, and it also authorizes over \$2 billion in new debt spending. The Virginia House passed this bill, 54-43, on March 7, 2020. The Virginia Senate passed it, 23-16, on March 8, 2020.

HB 1451

MANDATORY RENEWABLE ENERGY **STANDARD**

(CFGF OPPOSES)

This bill replaces the state's existing voluntary renewable energy portfolio standard (RPS) program with a mandatory one. Electric utilities will be forced to generate or purchase increasing percentages of renewable energy until the year 2050 when all electric power must be renewable. If a company fails to meet these new standards, they will be forced to pay a tax called a "deficiency payment." This mandate could come at a huge price, resulting in higher prices for consumers and greater government bureaucracy and spending.

The Virginia House passed this bill, 52-47, on February 11, 2020. The Virginia Senate passed it, 22-18, on February 24, 2020.

HB 1498

CORPORATE WELFARE FOR MERCK

(CFGF OPPOSES)

While the legislation doesn't explicitly say it, this bill was created so that one company - Merck - could receive a direct cash payment of over \$7.5 million plus \$2.5 million in indirect benefits if certain performance standards are met. This is corporate welfare where lawmakers and bureaucrats get to pick winners and losers in the marketplace. This is not a core function of government. The Virginia House passed this bill, 91-7, on January 31, 2020. The Virginia Senate passed it, 38-0, on February 21, 2020.

HB 1503

HEALTHCARE MANDATE FOR AUTISM

(CFGF OPPOSES)

This bill mandates that health insurance plans sold on the individual market and the small group market include coverage for autism spectrum

disorder. When lawmakers mandate insurance coverage for various medical conditions, it reduces healthcare freedom and drives up the price for everyone else. The Virginia Senate passed this bill, 40-0, on February 20, 2020. The Virginia House passed it, 97-1, on February 24, 2020.

HB 1562

MUSIC THERAPY LICENSURE

(CFGF OPPOSES)

Occupational licensure laws restrict innovation and job growth. It's also a prime example of regulatory capture where industry controls its own competition through the political process. This bill would establish an advisory board to help create a regulatory structure to license music therapists in the state. Under this law, unlicensed people will now be prevented from practicing music therapy. The Virginia House passed the bill, 92-5, on January 27, 2020. The Virginia Senate passed it, 40-0, on February 17, 2020.

HB 1602

SUBSIDIES FOR PRIVATE AIRLINES

(CFGF OPPOSES)

This bill creates a new slush fund called the Governor's New Airline Service Incentive Fund. The new fund will use tax dollars to promote and advertise new air service routes for airports in Virginia. This is not a core function of government and should be handled by the private sector. The Virginia Senate passed this bill, 40-0, on February 27, 2020. The Virginia House passed it, 88-10, on March 7, 2020.

SB 182

EXPAND PROJECT LABOR AGREEMENTS

(CFGF OPPOSES)

This bill authorizes any state or local government to require bidders to enter into or adhere to project labor agreements on public works projects. This will artificially raise the cost of labor for public works resulting in a higher price tag for taxpayers. The Virginia House passed this bill, 55-45, on February 28, 2020. The Virginia Senate passed it, 21-19, on March 2, 2020.

SB 404

PROHIBIT SHORT TERM HEALTHCARE **POLICIES**

(CFGF OPPOSES)

This bill will prohibit health insurance companies from offering short term policies that exceed 3 months in duration or that can be renewed or extended. This reduces consumer choice and healthcare freedom while stripping customers of their insurance if they like it. The Virginia House passed this bill, 55-43, on March 5, 2020. The Virginia Senate passed it, 21-19, on March 7, 2020.

SB480

PROHIBIT COMPETITION FROM LOW WAGE **EMPLOYEES**

(CFGF OPPOSES)

Allowing employers and employees to enter into voluntary contracts with each other is at the heart of economic freedom and the ability to ignite growth and innovation. This bill threatens that freedom by prohibiting employers from entering a covenant not to compete between an employer and a low-wage employee. Also, it allows any employee subject to such a covenant

to bring a civil action against an employer. The Virginia House passed a similar bill, HB 330, on March 4, 2020 by a vote of 86-6. The Virginia Senate passed this bill on March 7, 2020, by a vote of 34-6.

SB 713

ART THERAPY LICENSURE

(CFGF OPPOSES)

Occupational licensure laws restrict innovation and job growth. It is also a prime example of regulatory capture where industry controls its own competition through the political process. This bill creates a whole new regulatory regime to license art therapists and art therapist associates who practice in Virginia. The Virginia Senate passed this bill, 39-0, on February 4, 2020. The Virginia House passed it, 75-22, on February 21, 2020.

SB 817

IDENTIFY NUCLEAR ENERGY AS CLEAN ENERGY

(CFGF SUPPORTS)

This bill states that if Virginia undertakes,

oversees, regulates, or permits any clean energy initiative or carbon-free energy initiative, then nuclear energy shall be considered a clean energy source. This is a pro-growth effort that could help lower the cost of energy for all taxpayers across the state. The Virginia Senate passed this bill, 39-0, on January 24, 2020. The Virginia House passed it, 65-35, on February 27, 2020.

SB 1044

LICENSING FOR FUNERAL DIRECTORS AND EMBALMERS

(CFGF OPPOSES)

Occupational licensure laws restrict innovation and job growth. It is also a prime example of regulatory capture where industry controls its own competition through the political process. This bill directs the Board of Funeral Directors and Embalmers to create regulations that establish the requirements of licensure for funeral directors and embalmers. The Virginia Senate passed this bill, 40-0, on February 4, 2020. The Virginia House passed this bill, 76-18, on March 3, 2020.

ABOUT THE FOUNDATION

Virginia 2020 | House Vote Descriptions

HB 119

STATE CONTROL OF THE WORD "MILK" (CFGF OPPOSES)

This bill would narrowly define milk as the "lacteal secretion of a healthy hooved mammal" and therefore ban all products misbranded as milk. Products like almond milk and soy milk are named as such because its producers want to compete against animal milk. For the government to prevent this is to stifle commercial speech and reduce competition. The Virginia House passed this bill, 66-32, on January 29, 2020. The Virginia Senate passed it, 24-16, on February 27, 2020.

HB 330

PROHIBIT COMPETITION FROM LOW WAGE **EMPLOYEES**

(CFGF OPPOSES)

Allowing employers and employees to enter into voluntary contracts with each other is at the heart of economic freedom and the ability to ignite growth and innovation. This

bill threatens that freedom by prohibiting employers from entering a covenant not to compete between an employer and a lowwage employee. Also, it allows any employee subject to such a covenant to bring a civil action against an employer. The Virginia House passed this bill, 86-6, on March 4, 2020. The Virginia Senate passed a similar bill, SB 480, on March 7, 2020, by a vote of 34-6.

HB 395

INCREASE MINIMUM WAGE

(CFGF OPPOSES)

The minimum wage is a price control on labor. Increasing or expanding the minimum wage often has the opposite desired effect, leading to job losses and shortages. This bill raises the state's minimum wage gradually from its current federally mandated \$7.25 per hour in 2020 to \$15.00 per hour in 2026. The Virginia House passed this bill, 53-45, on March 7, 2020. The Virginia Senate passed it, 21-17, on March 8, 2020.

HB 408

EXTENDING GREEN JOB SUBSIDIES

(CFGF OPPOSES)

This bill would extend the sunset date for the Green Job Creation Tax Credit from January 1, 2021, to January 1, 2025. This tax credit is an example of social engineering using arbitrary targets and dollar amounts. It's not a core function of government, but instead egregious corporate welfare. The Virginia Senate passed it, 27-13, on February 20, 2020. The Virginia House passed it, 58-40, on February 24, 2020.

HB 534

NEW PLASTIC BAG TAX

(CFGF OPPOSES)

This bill would allow local governments to charge a 5-cent tax on plastic bags provided to customers by certain retailers. This is social engineering and is not an equitable way to raise taxes for financing the core functions of government. The Virginia House passed this bill, 52-47, on March 5, 2020. The Virginia

HB 570

ALLOW INCOMPETENT TEACHERS TO KEEP WORKING

(CFGF OPPOSES)

This bill would remove the definition of "incompetency" for the purpose of establishing grounds for the dismissal of public school teachers. Teachers need to be subjected to more competition, not less, in order to make sure that the very best instructors are teaching our children. The Virginia House passed this bill, 57-42, on February 4, 2020. The Virginia Senate passed it, 22-18, on February 17, 2020.

HB 582

ALLOW PUBLIC EMPLOYEES TO UNIONIZE (CFGF OPPOSES)

This bill would permit counties, cities, and towns to adopt local ordinances authorizing them to recognize labor unions for certain public employees, including employees at governmentrun schools. This will further raise the cost of maintaining government bureaucracies, placing

a higher burden on taxpayers. The Virginia House passed this bill, 53-46, on March 7, 2020. The Virginia Senate passed it, 21-18 on March 8, 2020.

HB 755

NEW UGLY PROPERTY TAX

(CFGF OPPOSES)

This bill allows certain local governments to levy a higher property tax on properties that it deems as blighted or having derelict structures. This is social engineering and is not an equitable way to raise taxes for financing the core functions of government. The Virginia Senate passed this bill, 23-15, on February 21, 2020. The Virginia House passed it, 59-39, on February 25, 2020.

HB 1141

VIRGINIA HEALTHCARE MUST BE **OBAMACARE**

(CFGF OPPOSES)

This bill would require health insurance companies to only offer plans that are compliant with Obamacare requirements, even if Obamacare is repealed. This will reduce healthcare freedom and choice while raising prices for everyone. The Virginia House passed this bill, 61-37, on March 5, 2020. The Virginia Senate passed it, 22-18, on the same day.

HB 1162

NEW AUTHORITY TO PURSUE ENVIRONMENTAL JUSTICE

(CFGF OPPOSES)

This bill states that Virginia's Department of Environment Quality is now supposed to further "environmental justice". Such a policy will likely reduce economic growth by rejecting building permits, tightening environmental regulations. and restricting development, especially in lowincome areas. The Virginia Senate passed this bill, 21-19, on February 24, 2020. The Virginia House passed it, 53-43, on February 26, 2020.

HB 123

MORE POLITICAL SPEECH REGULATIONS

(CFGF OPPOSES)

Current law states that political advertisements must have a disclosure of at least a font size of seven. This bill would require the font size to

be proportional to the advertisement, setting up a myriad of regulations since candidates use different methods of advertisements. The Virginia House passed this bill, 81-14, on February 6, 2020. The Virginia Senate passed it, 35-5, on February 24, 2020.

HB 1318

EXTENSION OF HOLLYWOOD TAX CREDITS (CFGF OPPOSES)

This bill extends the sunset deadline from January 2022 to January 2027 for the motion picture tax credit that the state currently offers. This is corporate welfare and is not a core function of government. The Virginia House passed this bill, 67-26, on March 4, 2020. The Virginia Senate passed it, 35-4, on March 7, 2020.

HB 1361

CORPORATE WELFARE FOR TRUCK **COMPANY**

(CFGF OPPOSES)

While the legislation doesn't explicitly say it, this bill was created so that one company - The Volvo Group - could receive a direct cash payment of over \$16 million if certain performance standards are met. This is corporate welfare where lawmakers and bureaucrats get to pick winners and losers in the marketplace. This is not a core function of government. The Virginia House passed this bill, 90-9, on January 31, 2020. The Virginia Senate passed it, 40-0, on February 20, 2020.

HB 1414

HUGE TRANSPORTATION TAX AND SPEND BILL

(CFGF OPPOSES)

This massive bill would increase the state gas tax by ten cents over two years and then index it to inflation. It would also impose a new fee on electric or alternative fuel vehicles, and impose a new regional fuels sales tax in parts of the state that don't already have one. It also creates a new rail authority that would be allowed to acquire land via eminent domain to promote and create new rail service. The bill would raise over \$168 million a year in new revenue from the tax hikes, and it also

authorizes over \$2 billion in new debt spending. The Virginia House passed this bill, 54-43, on March 7, 2020. The Virginia Senate passed it, 23-16, on March 8, 2020.

HB 1451

MANDATORY RENEWABLE ENERGY **STANDARD**

(CFGF OPPOSES)

This bill replaces the state's existing voluntary renewable energy portfolio standard (RPS) program with a mandatory one. Electric utilities will be forced to generate or purchase increasing percentages of renewable energy until the year 2050 when all electric power must be renewable. If a company fails to meet these new standards, they will be forced to pay a tax called a "deficiency payment." This mandate could come at a huge price, resulting in higher prices for consumers and greater government bureaucracy and spending. The Virginia House passed this bill, 52-47, on February 11, 2020. The Virginia Senate passed it, 22-18, on February 24, 2020.

HB 1498

CORPORATE WELFARE FOR MERCK

(CFGF OPPOSES)

While the legislation doesn't explicitly say it, this bill was created so that one company -Merck - could receive a direct cash payment of over \$7.5 million plus \$2.5 million in indirect benefits if certain performance standards are met. This is corporate welfare where lawmakers and bureaucrats get to pick winners and losers in the marketplace. This is not a core function of government. The Virginia House passed this bill, 91-7, on January 31, 2020. The Virginia Senate passed it, 38-0, on February 21, 2020.

HB 1503

HEALTHCARE MANDATE FOR AUTISM

(CFGF OPPOSES)

This bill mandates that health insurance plans sold on the individual market and the small group market include coverage for autism spectrum disorder. When lawmakers mandate insurance coverage for various medical conditions, it reduces healthcare freedom and drives up the price for everyone else. The Virginia Senate passed this bill, 40-0, on February 20, 2020. The Virginia House passed it, 97-1, on February 24, 2020.

HB 1562

MUSIC THERAPY LICENSURE

(CFGF OPPOSES)

Occupational licensure laws restrict innovation and job growth. It's also a prime example of regulatory capture where industry controls its own competition through the political process. This bill would establish an advisory board to help create a regulatory structure to license music therapists in the state. Under this law, unlicensed people will now be prevented from practicing music therapy. The Virginia House passed the bill, 92-5, on January 27, 2020. The Virginia Senate passed it, 40-0, on February 17, 2020.

HB 1602

SUBSIDIES FOR PRIVATE AIRLINES

(CFGF OPPOSES)

This bill creates a new slush fund called the Governor's New Airline Service Incentive Fund. The new fund will use tax dollars to promote and advertise new air service routes for airports in Virginia. This is not a core function of government and should be handled by the private sector. The Virginia Senate passed this bill, 40-0, on February 27, 2020. The Virginia House passed it. 88-10, on March 7, 2020.

SB 182

EXPAND PROJECT LABOR AGREEMENTS

(CFGF OPPOSES)

This bill authorizes any state or local government to require bidders to enter into or adhere to project labor agreements on public works projects. This will artificially raise the cost of labor for public works resulting in a higher price tag for taxpayers. The Virginia House passed this bill, 55-45, on February 28, 2020. The Virginia Senate passed it, 21-19, on March 2, 2020.

SB 404

PROHIBIT SHORT TERM HEALTHCARE **POLICIES**

(CFGF OPPOSES)

This bill will prohibit health insurance companies from offering short term policies that exceed 3 months in duration or that can be renewed or

extended. This reduces consumer choice and healthcare freedom while stripping customers of their insurance if they like it. The Virginia House passed this bill, 55-43, on March 5, 2020. The Virginia Senate passed it, 21-19, on March 7, 2020.

SB 713

ART THERAPY LICENSURE

(CFGF OPPOSES)

Occupational licensure laws restrict innovation and job growth. It is also a prime example of regulatory capture where industry controls its own competition through the political process. This bill creates a whole new regulatory regime to license art therapists and art therapist associates who practice in Virginia. The Virginia Senate passed this bill, 39-0, on February 4, 2020. The Virginia House passed it, 75-22, on February 21, 2020.

SB 817

IDENTIFY NUCLEAR ENERGY AS CLEAN ENERGY

(CFGF SUPPORTS)

This bill states that if Virginia undertakes,

oversees, regulates, or permits any clean energy initiative or carbon-free energy initiative, then nuclear energy shall be considered a clean energy source. This is a pro-growth effort that could help lower the cost of energy for all taxpayers across the state. The Virginia Senate passed this bill, 39-0, on January 24, 2020. The Virginia House passed it, 65-35, on February 27, 2020.

SB 1044

LICENSING FOR FUNERAL DIRECTORS AND EMBALMERS

(CFGF OPPOSES)

Occupational licensure laws restrict innovation and job growth. It is also a prime example of regulatory capture where industry controls its own competition through the political process. This bill directs the Board of Funeral Directors and Embalmers to create regulations that establish the requirements of licensure for funeral directors and embalmers. The Virginia Senate passed this bill, 40-0, on February 4, 2020. The Virginia House passed this bill, 76-18, on March 3, 2020.
